

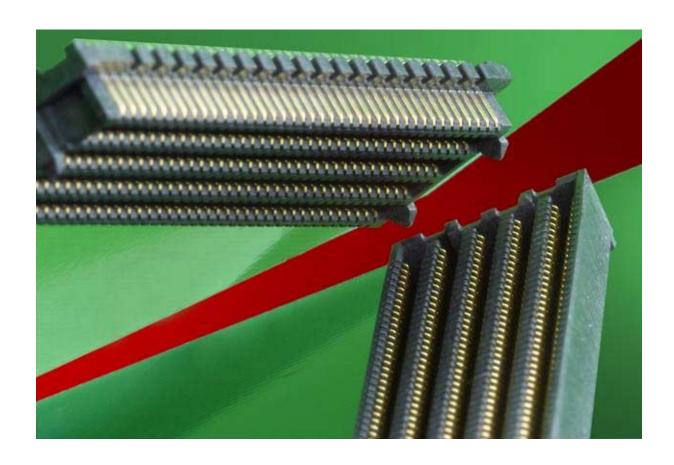

#### 1.0 INTRODUCTION

Molex and Samtec have entered a cross licensing agreement for SEARAY™, a high density mezzanine interconnect system. This collaborative agreement requires that both companies provide product that has similar performance and is intermateable. Comparable mechanical performance has been established by dimension verification of the design and materials utilized in manufacturing. The data in this report will support the electrical and mechanical intermateability between Molex and Samtec for SEARAY™.

In order to ensure future product derivatives of SEARAY™ are intermateable, both organizations will conduct regular design reviews. Molex and Samtec are cooperating on a technical level to ensure a dual sourcing strategy can be supported for our end customers. The premise for our licensing agreement is to fulfill the industry needs for assurance of supply, repeatable manufacturing processes, and reliability of the mating interface.

#### 2.0 SCOPE

This specification defines the intermateability requirements including electrical and mechanical performance and test sequences depicting that both the Molex and Samtec SEARAY™ product families are intermateable and the separable interface is compatible. SEARAY™ interconnect system consists of a mated pair of connectors which provide various height combinations to create various PCB stack heights. Product variations used in testing are considered representative of the entire SEARAY<sup>TM</sup> product family. All variations that are not tooled at the time of testing are considered covered based on test results.

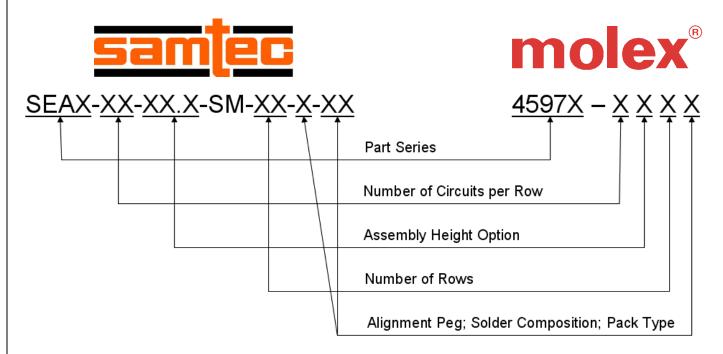

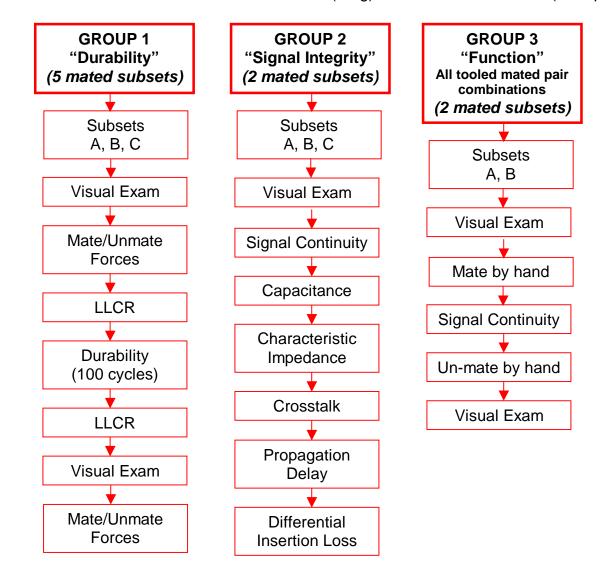
